## CARES Act Phoenix Refugee & Asylee Relief Grant Pre-Contract Orientation July 9, 2020

## QUESTIONS:

1. What is the difference between 501 (c) 3 and 401 (c)?

I googled the 501(c)(3) and 401(c) question - they both refer to IRS classifications and the primary difference is the 501(c)(3) refers to a formal classification of NOT FOR PROFIT organizations while the 401(c) refers to a formal classification of "self-employed" individuals and "owner employees" As Wathsna mention we may want to discuss with Dawn before posting the responses.

- 2. If we don't have a physical location, do we still have to fill the ADA questionnaire?

  More guidance will be provided on this item.
- 3. The activities that are reimburse should start no earlier than the contract is signed? Lie 9/1/2020? Your organization can perform scope of work activities from July 1, 2020 forward.

Expenses incurred from July 1, 2020 forward cannot be reimbursed until the contract is fully executed.

4. On our W-9, what line does our DUNS # go?

There is not a field for the DUNS number on the W-9 form. Please provide this information with the SAM.gov registration verification.

5. Can 20% of grant be expensed now (before contracted)?

Per the RFP, page 6, no program expenses incurred prior to award notification will be reimbursed. No more than 20% of the overall awarded funds can be used for reimbursement of costs incurred prior to contracting. Any expenses incurred prior to contract must be approved by city staff prior to being incurred. Documentation to support all expenditures will be required.

6. Do we get reimbursed as we go along?

Monthly reimbursement packets are due to your assignment project manager monthly. More guidance will be provided during the billing template training. The billing template training will be scheduled upon contract execution.

7. What about organizations who are awarded this grant for the first time, and do not have funding at the moment to pay in advance. Can they receive some funding in advance?

Per the RFP, page 6, no program expenses incurred prior to award notification will be reimbursed. No more than 20% of the overall awarded funds can be used for reimbursement of costs incurred prior to contracting. Any expenses incurred prior to contract must be approved by city staff prior to being incurred. Documentation to support all expenditures will be required.
