Fatal Collision/Robbery Investigation

On June 10, 2021, at approximately 3:47 p.m., Phoenix police officers responded to a call near 17th Avenue and Missouri of a stolen vehicle. Officers learned a female was in her car, when a man, who was known to her, struck her in the face, and took her vehicle. The victim was able to get out of the car before the male fled with it. The vehicle which was stolen was a dark blue 2010 Cadillac SRX. That incident number is 2021-901942.

Approximately three minutes after the call of the stolen vehicle was received, additional calls were received by 911 reporting a multi-vehicle collision in the intersection of 7th Avenue and Missouri. One of the vehicles involved matched the description of the stolen vehicle. Officers and Firefighters responded and located a five-vehicle collision.

The Phoenix Fire Department began medical treatment and pronounced an 18-year-old female and 16-year-old female deceased on scene. Additional medical personnel arrived and transported a total

of five people from the scene, including a 45-year-old female with extremely critical injuries, who unfortunately was later pronounced deceased at the hospital.

Investigators learned from witnesses and evidence at the scene that the Cadillac SRX, driven by the suspect, was eastbound on Missouri at a high rate of speed and ran the red light at 7th Avenue. The Cadillac collided with a white Honda Civic that was travelling south on 7th Avenue with three occupants. All three of those occupants lost their lives as a result of the injuries they sustained in the collision. Those three individuals were a mother and her two teen children.

The force of that collision caused the Cadillac and Honda to impact a 2019 Dodge Ram pickup truck that had been travelling north on 7th Avenue that vehicle was occupied by an adult and child, and one of those occupants was transported to the hospital for precautionary reasons. The force of that collision pushed the Dodge into a City of Phoenix Bus, that was also travelling north. The bus had one driver and two passengers on board, and none of them required transportation for medical care.

The Cadillac continued east and struck a pedestrian who was crossing Missouri in the crosswalk on the east side of 7th Avenue. That pedestrian was transported to the hospital with non-life-threatening injuries.

The Cadillac then struck a Chevy Malibu which was waiting on Missouri at the red light to travel west. The occupant of the malibu was transported to the hospital with non-life-threatening injuries.

The driver of the Cadillac was transported to the hospital for injuries sustained in the collision. Impairment and speed are both contributing factors in this collision. Once released from the hospital he will be booked on various charges.
